THE HOME TEST KIT

The kit in front of you is all you need to obtain the most accurate DNA test using some of the latest DNA analysis technologies and methodologies in the world today. You only need to rub the buccal swab on the inside of the cheek for several seconds, and mail them back to us. We will then analyze specific areas of DNA to give you a test result.

Enclosed you will find the Sample Submission Form, which you must fill out. You only need to include details of those people who are being tested. Write on the Sample Submission Form the name of each person being testing.

TAKING A SIBLING TEST

We have a range of high quality sibling tests from our ISO-17025 Accredited laboratory. DNA SOLUTIONS can offer you various tests, such as a sibling test, Y chromosome test for male lineage or an X Chromosome Test for female relationship. Prices below are for testing 2 people. Often it is useful to include DNA from either parent or additional siblings to increase the accuracy of the test.

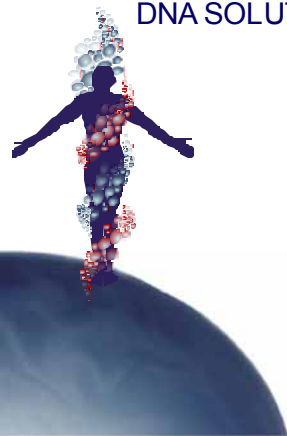

- **Y CHROMOSOME** Test, for Male relationships, (Brother-Brother) - **\$290**
- **X CHROMOSOME** Test, for Female relationships, (Sister-Sister) - **\$375**
- **MITOCHONDRIAL** Test, for determine mother relationships, - **\$295**
- **FULL SIBLING** Test, for mixed relationships, (Brother-Sister) - **\$395**

ABOUT THE SIBLING TESTS

Y Chromosome Test - To test males only. The father passes his Y chromosome along to each of his sons, thus making his sons male. Therefore, this is a direct inheritance of the Y chromosome that does not get complicated by the sex genes received from the mother.

Possible scenarios in which a Y test will answer the question:

1. Brothers who want to know if they have the same father.
2. Grandfather/Grandson trying to find out if the son of the grandfather is the father of the grandson.
3. Uncle/Nephew trying to find out if the brother of the uncle is the father of the nephew (requires the father and uncle to have the same father).
4. Cousins if the cousins' fathers are brothers (who share the same father).
5. Further extension of paternal lineages as long as the paternal lineage of father-son-father-son is unbroken, we can test very distantly related paternal relatives.

X Chromosome Test - To test female to female. Males are XY and females are XX. To make a female child, the father must donate his X chromosome and the mother donates either one of hers. To make a male child, the father donates his Y chromosome and the mother donates either one of her X's.

Possible scenarios in which an X test will answer the question:

1. Sisters with different mothers and want to know if they have the same father.
2. Sisters with the same mother, want to know if they have the same father, must provide a sample from the mother.
3. Grandmother/Granddaughter trying to find out if the son of the grandmother is the father of the granddaughter.

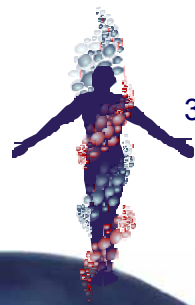
Mitochondrial Test - Mitochondrial DNA is passed from Mother to children. Men have Mitochondrial DNA but they do not pass it on. Mitochondrial DNA is only inherited from the Mother, so it is the ideal test to see if siblings have the same biological mother. The accuracy of the test depends very much on the type of mitochondrial DNA you have. If two matching people have a rare type of Mitochondrial DNA then they are more likely to be siblings, than two people who match with a common type of mitochondrial DNA. The probability of you being related is calculated after we know what type of DNA you have.

Full Sibling Test - The full sibling DNA test works by analyzing DNA in each sibling and calculating the likelihood of them being related or not. This test is 90% accurate and looks at the amount of DNA sharing between siblings. Accuracy is drastically increased with DNA from other siblings or the mother.

Possible scenarios in which a Full Sibling test will answer the question:

1. Any two siblings trying to determine if they are siblings. We can tell them if they are full siblings (both parents in common), not related (no parents in common), or half siblings (one parent in common, but we will not be able to tell them which parent they have in common).
2. If you are trying to determine if someone is the father, but cannot obtain his sample, we can test the child in question and the alleged father's parents. We do need both of his parents to do this test. Similarly, we can use both maternal grandparents and determine if their daughter was the child's mother.
3. Any combination of aunt/uncle/niece/nephew and we will calculate statistics about the likelihood that they are related.

PROCEDURE FOR CHEEK SWAB COLLECTION

If you are not using DNA SOLUTIONS swabs, as provided in our DNA kit, you can use 4 Q-tips (cotton buds) for each person being tested.

If you are sending us a discrete sample, then a used toothbrush is the best discreet option.

STEPS:

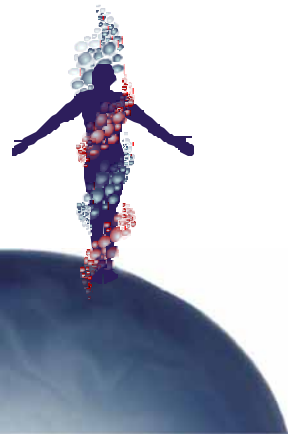
1. Label a **paper-bag** or **paper-envelope** with name of the person to be tested Please ensure the same information is written on the Sample Form (the following page).
2. Take the brand new **buccal swab** from its packet and gently rub the bristled end on the inside of the cheek up and down for around **10 to 15** seconds. Using the same **buccal swab** repeat again, on the inside of the other cheek.
3. **Instead of the buccal swab you can use 4 Q-tips (cotton buds).**

You **MUST cut the head of one side of the Q-tip**, so we KNOW which side of the Q-tip contains the DNA! After you have cut the head of the Q-tips on one side, hold the handles of 2 cotton buds in one hand and rub the head of the bud on the inside of the cheek. Rubbing up and down firmly inside the cheek for at least **15** seconds.

Repeat on the other side of the cheek with the other 2 cotton buds (4 in total, 2 per cheek)

4. Immediately place the cotton buds or **buccal swab** into a paper-bag or envelope (DO NOT use a plastic bag) clearly labeled for that person, and mail with forms and payment to DNA SOLUTIONS.
